Sandi stated that we are going to use every legal means at our disposal to get past dues collected.

Walters asked about the balance sheet, and if we are in the black/red.

Nate asked if the numbers were current, or if they were from 2022-year end.

Paul asked if people gave a reason why they didn't pay.

Kim made a motion to accept. Nathan seconded. Report accepted.

### **Grounds Report**

Kory stated that the primary job of the board is to maintain the common area, fence and entrances.

Kory gave an update on the fence bidding and replacement. He stated that Ron & Tom's repair was the vendor chosen to the work. Phase 1 was completed in 2022. Phase 2 started May 2 along Military.

The board also removes litter, and trash as well as a fall cleanup.

We trimmed common trees and shrubs, and planted numerous new plants.

Kory gave an update on our current vendors for mowing, mulching, fertilizing and fencing.

Snow removal is done by the city, and we have no control over it.

Kory thanked everyone for paying into the fence assessment.

Kathleen thanked us for all the work that we do.

# **Covenants Report**

Brian read the covenants report, and gave an update on covenants.

There was a lot of discussion about problems in the neighborhood with yards, trees, and sheds.

# **Social Committee**

There were 35 proxies, which voted both. The results were 53 for Nestor, and 51 for Eldon.
